**WHEREAS**, Port Area Barangay particularly Strong Boulevard was identified as the site of the proposed infrastructure project.


**NOW THEREFORE**, upon motion of Councilor Ar-Jhemar K. Ajibon, duly seconded by all members, **BE IT**
