A RESOLUTION GRANTING HER HONOR, MAYOR SITTI DJALIA T. HATAMAN, AUTHORITY TO PURCHASE TWO (2) VEHICLES , ONE (1) PICK-UP TYPE AND ONE (1) VAN TYPE, TO BE USED FOR TRANSPORTING PATIENTS, LOCALLY STRANDED INDIVIDUALS (LSIS), AND RETURNING OVERSEAS FILIPINOS (ROFs), IN ISABELA CITY, BASILAN PROVINCE.

WHEREAS, it is the mandate of the Local Government Unit to provide its constituents basic services that will improve sustainability;

WHEREAS, the estimated value of one (1) Pick-up type of Two Million One Hundred Fifty Thousand Pesos (P2,150,000.00) and the van type with an estimated value of One Million Nine Hundred Fifty Thousand Pesos (P1,950,000.00), taken from the Special Purpose Funds-Covid-19 Financial Assistance.


