A RESOLUTION RESPECTFULLY REQUESTING ALL FORTY-FIVE BARANGAY CHAIRPERSONS OF THE CITY OF ISABELA, PROVINCE OF BASILAN TO STRICTLY ADHERE AND ABIDE WITH THE DIRECTIVES AND GUIDELINES OF THE NATIONAL INTER-AGENCY TASK FORCE ON COVID-19 ON THE ESTABLISHMENT OF BARANGAY ISOLATION UNITS (BIUS) IN THEIR RESPECTIVE BARANGAYS.

WHEREAS, It is the policy of the state and of the local government units to ensure the safety and well-being of its people and to ensure the effective and efficient delivery of basic services;

WHEREAS, since the start of the Coronavirus Disease (COVID19) pandemic, the City and Barangay Local Government Units imposes different measures and initiatives to curb the spread of the virus within the City;

WHEREAS, in the past weeks, there is a notable spike of positive cases in the City which provoked the City Government to tighten and impose stricter measures to suppress the spread of the virus;

WHEREAS, as there is a sudden increase of cases, the bed capacity of our City Isolation Facility as well as our government hospital and all of the private hospitals in the city are now reaching critical capacity level;

WHEREAS, to augment the isolation units being managed by the city, the Inter-Agency Task Force and the National Task Force on COVID19 has issued guidelines mandating Barangay Local Government Units to establish their respective Barangay Isolation Units which will be manned by their respective Barangay Health Emergency Response Teams (BHERT);

WHEREAS, Memorandum Circular No. 2020-023 mandates all Barangay Local Government Units to establish their Barangay Local Government Units;

WHEREAS, despite the Memorandum Circular imposed by the Department of Interior and Local Government, there are other Barangay Local Government Units who failed to establish their own BIUs;


NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members, IT WAS

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, respectfully requests all forty-five Barangay Chairpersons of the City of Isabela, Province of Basilan, to strictly adhere and abide with the directives and guidelines of the National Inter-Agency Task Force on Covid-19, on the establishment of Barangay Isolation Units (BIUs), in their respective barangays.
