**A RESOLUTION RESPECTFULLY REQUESTING THE ISABELA CITY POLICE STATION, DEPARTMENT OF TRADE AND INDUSTRY, BUSINESS PERMITS AND LICENSING DIVISION, LOCAL ECONOMIC DEVELOPMENT INVESTMENT PROMOTIONS OFFICE, AND OFFICE OF THE CITY HEALTH, ALL OF THIS CITY, TO IMPOSE A CRACKDOWN ON ALL ILLEGAL SLIMMING AND WHITENING PRODUCTS BEING SOLD IN THE CITY OF ISABELA, PROVINCE OF BASILAN.**

**WHEREAS**, it is the policy of the state and of the local government units to ensure the safety and well-being of its citizens;

**WHEREAS**, there have been reports that several unregistered, unsafe slimming and whitening products are being sold in local and online markets;

**WHEREAS**, these products, since unregistered, did not pass the safety standards and quality assurance being imposed by government agencies such as the Food and Drug Administration, thereby imposing potential risk to customers availing these products;

**WHEREAS**, there are reported incidents of serious side effects to those people who consumed these unregistered products;

**WHEREAS**, should the concerned agencies fail to look into this matter, more customers may face further risk of ill-fated side effects;

**WHEREAS**, there is a need for the local government agencies to strictly monitor and impose a crackdown on all unregistered slimming and beauty health products to ensure the safety of the constituents of the City of Isabela de Basilan.

**NOW WHEREFORE**, upon motion of Councilor Jashim I. Tiplani, duly seconded by all members present, **IT WAS**

**RESOLVED**, as it I hereby resolved, that the Sangguniang Panlungsod of Isabela, Province of Basilan, respectfully requests the Isabela City Police Station, Department of Trade and Industry, Business Permits and Licensing Division, Local Economic Development Investment Promotions Office, and Office of the City Health, all Of this City, to impose a crackdown on all illegal slimming and whitening products being sold in the City of Isabela, Province of Basilan.
