**A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITTI DJALIA A. TURABIN-HATAMAN TO ENTER INTO MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND METTAMATCH TRADING INCORPORATED/CONNECTED WOMEN IN RELATION TO THE SOCIAL IMPACT TECH START-UP WHICH OFFERS ONLINE SKILLS DEVELOPMENT AND REMOTE WORK OPPORTUNITIES TO WOMEN BATCH 3.**

**WHEREAS,** Sec. 455 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines states that local chief executives shall *"represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;"*

**WHEREAS,** a letter was forwarded to the honorable members of the Sangguniang Panlungsod dated August 25, 2021 of her honor, Mayor Sitti Djalia A. Turabin-Hataman requesting the honorable members to pass a resolution granting authority to her honor to enter a Memorandum of Agreement by and between the City Government of Isabela and METTAMATCH Trading Incorporated/Connecting Women;

**WHEREAS,** the said Memorandum of Agreement is in relation to the Social Impact Tech Start-Up which offers online skills development and remote work opportunities to women;

**WHEREAS,** the said program will greatly benefit the women sector of the City of Isabela and thus, the said authority is hereby needed by the Local Chief Executive;


**NOW, THEREFORE,** on motion of Councilor Khaleedsher M. Asarul, duly seconded by all members present, be it

**RESOLVED,** as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela authorizes her honor, Mayor Sitti Djalia A. Turabin-Hataman to enter into Memorandum of Agreement by and between the City Government of Isabela and METTAMATCH Trading Incorporated/Connected Women in relation to the Social Impact Tech Start-Up.


