**WHEREAS**, the cultural mapping project will focus on the collection, recording, analysis and synthesis of information that will describe the cultural resources, networks, links and patterns of usage of the community;

**WHEREAS**, the Indigenous Cultural Communities, are being represented by Raja Abdulkuddus A. Salihin, Yakan ICC/IP, Mary May B. Julhari, Badjau ICC/IP and Abdurasid A. Omar, Sama Bangingi ICC/IP, as the second party and Mercilyn B. Hatad, Acting Regional Director, National Commission on Indigenous Peoples, as the third party .


**NOW WHEREFORE**, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by all members present, **BE IT**
