A RESOLUTION REQUESTING KAGAWAD CARMELITA E. GREGORIO, RESPONDENT, TO ANSWER AN ADMINISTRATIVE COMPLAINT, FILED BY HONORABLE RIGOBERTO E. DEMCO, COMPLAINANT, FOR GROSS MISCONDUCT IN OFFICE, ABUSE OF AUTHORITY AND CONDUCT UNBECOMING OF A PUBLIC OFFICIAL, WITHIN THE PERIOD OF FIFTEEN (15) DAYS.

WHEREAS, an administrative case was filed with the Office of the Sangguniang Panlungsod, on September 29, 2021, by Honorable Rigoberto E. Demco, Punong Barangay, against Kagawad Carmelita E. Gregorio, all of Binuangan Barangay, this City, for Gross Misconduct in Office, Abuse of Authority and Conduct Unbecoming of a Public Official;

WHEREAS, in the verified affidavit of complainant, it was stated among others that the incident happened during the Regular Session, held last September 18, 2021;

WHEREAS, the complainant averred that the respondent uttered unsavory words which besmirched his reputation;

WHEREAS, it was required from the respondent a verified answer to determine merits of the complaint, before a formal investigation will commence.

NOW WHEREFORE, upon motion of Councilor Candu I. Muarip, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, Province of Basilan, requests Kagawad Carmelita E. Gregorio, Respondent, to answer an administrative complaint, filed by Honorable Rigoberto E. Demco, Complainant, for Gross Misconduct in Office, Abuse of Authority and Conduct Unbecoming of a Public Official, within the period of fifteen (15) days.
