A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITI DJALIA T. HATAMAN, MAYOR, THIS CITY, TO PURCHASE ONE (1) UNIT DROP SIDE TRUCK TYPE, TO BE USED AS A DISASTER RESPONSE VEHICLE.

WHEREAS, Presidential Proclamation No. 922, declares the entire nation under public health emergency, to combat the COVID 19 outbreak that threatens our national security which requires a whole government response and would capacitate local government units to appropriate urgent and critical measures to contain or prevent the spread of COVID 19 and its ill-effects;

WHEREAS, the acquisition of said vehicle is very much needed which shall be used as a disaster response vehicle which will transport patients and as a rapid deployment vehicle in case of emergencies and disasters in the City of Isabela, Province of Basilan.

WHEREAS, said purchases of one (1) unit drop side truck, in the amount of Two Million Six Hundred Thousand (P2,600,000.00) Pesos, shall be charged against the 70% of the 5% LDRRM Fund-Disaster Preparedness Procurement of Emergency Response Vehicles.


NOW WHEREFORE, upon motion of Councilor Jashim I. Tiplani, duly seconded by majority of the members present, **BE IT**
