A RESOLUTION CONCURRING AMENDMENTS TO USER ACCOUNT AND AUTHORIZING MR. ERNEST PAUL A. PINEDA, CASHIER II, AS THE NEW DEPUTIZED DISBURSING OFFICER AND AUTHORIZED MAKER OF THE DIGITAL BANKING OF THE DEVELOPMENT BANK OF THE PHILIPPINES.

WHEREAS, Sec. 455 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines states that local chief executives shall "*represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;*";

WHEREAS, Ms. Annafreida F. Raval, Cashier IV, of the Office of the City Treasurer, this City and the deputized Disbursing Officer and the authorized Maker of the digital banking of Development Bank of the Philippines, City Government of Isabela, died last November 9, 2021;

WHEREAS, her untimely demise has deferred some of the financial transactions as she is the deputized Disbursing Office and authorized maker of DBP's digital banking of the City Government of Isabela.

WHEREAS, a letter was forwarded to the honorable members of the Sangguniang Panlungsod dated November 16, 2021 of her honor, Mayor Sitti Djalia A. Turabin-Hataman requesting the honorable members of the august body to pass a resolution concurring the amendment of user account and to authorize Mr. Ernest Paul A. Pineda as the new deputized Disbursing Officer and authorized Maker of DBP's digital banking

WHEREAS, there is a need to pass this measure so as not to delay further the financial transactions in the City Government of Isabela particularly the salaries and wages of its employees.

NOW THEREFORE, on motion of Councilor Khaleedsher M. Asarul, duly seconded by all members present, be it

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela concurs to the amendments to user account and authorizes Mr. Ernest Paul A. Pineda, Cashier II, as the new Deputized Disbursing Officer and Authorized Maker of the Digital Banking of the Development Bank Of The Philippines.
