**A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITI DJALIA T. HATAMAN, MAYOR, THIS CITY, TO ENTER INTO A MEMORANDUM OF PARTNERSHIP AGREEMENT (MOPA), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGION 1X, AS PART OF THE LEGITIMIZATION PROCESS IN THE FORMULATION OF THE FORESHORE AND MANAGEMENT PLAN FOR CY 2021-2030.**

**WHEREAS**, Resolution No. 6324, of the Sangguniang Panlungsod of Isabela, Province of Basilan, approves the City Foreshore Development and Management Plan (CFDMP);

**WHEREAS**, the City Foreshore Development and Management Plan, shall be the guiding framework in the management scheme to be adopted particularly on the identification of legally, permissible, ecologically viable and compatible land uses of a particular area in the foreshore;

**WHEREAS**, the partnership to implement the plan towards a common goal will attain a foreshore with ecological balance and harmonious relation sustaining a relatively modern economic community resilient to disaster;

**WHEREAS**, Memorandum of Partnership Agreement (MOPA), will lead to the creation of the Foreshore Development and Management Council.

**BE IT RESOLVED**, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, grants authority to Honorable Sitti Djalía T. Hataman, Mayor, this City, to enter into a Memorandum of Partnership Agreement (MOPA), by and between the City Government of Isabela and the Department of Environment and Natural Resources (DENR) Region 1X, as part of the legitimization process in the formulation of the Foreshore and Management Plan For Cy 2021-2030.
