**A RESOLUTION CONCURRING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 09, S.2021, APPROVING THE REALIGNMENT OF SPECIAL TRUST FUND OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF), IN THE AMOUNT OF THREE MILLION FOUR HUNDRED THIRTY FIVE THOUSAND PESOS (P3,435,000.00).**

**WHEREAS**, Section 106, of the Local Government Code of 1991, mandates each Local Government Unit to prepare a comprehensive Multi-sectoral Development Plan, to be initiated by its Local development Council duly approved by its Sanggunian;

**WHEREAS**, CDC Resolution No. 09, S. 2021, approves the realignment of the unexpended Special Trust Fund of Local Disaster Risk Reduction and Management Fund (LDRRMF);

**WHEREAS**, the unexpended Local Disaster Risk Management Fund (LDRRMF) shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC).


**WHEREFORE**, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**
