A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITTI DJALIA A. TURABIN-HATAMAN, TO ENTER INTO A DEED OF DONATION BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF EDUCATION - ISABELA CITY SCHOOLS DIVISION IN RELATION TO THE HAPISABELA TELEDUKASYON PROGRAM.

WHEREAS, Sec. 455 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines states that local chief executives shall "*represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance*";

WHEREAS, a letter was forwarded to the Honorable Members of the Sangguniang Panlungsod dated September 7, 2021 of her honor, Mayor Sitti Djalia A. Turabin-Hataman and was received by the Office of the Sangguniang Panlungsod on the same day, requesting the Honorable Members to pass a resolution granting authority to Her Honor, to enter into a Deed of Donation by and between the City Government of Isabela and the Department of Education – Isabela City Schools Division;

WHEREAS, the said Deed of Donation is in relation to the HAPIsabela Teledukasyon Program of the City Government of Isabela and the Isabela City Schools Division, and Basilan Cable Home Network, Inc., which aims to provide quality alternative learning medium and opportunity for the students of Isabela City especially during this time of pandemic where most of the students are studying under the new normal type of learning.

WHEREAS, under the said donation, different equipment, and supplies will be turned-over to the HAPIsabela Teledukasyon which will further improve their services which will greatly benefit the students of the City of Isabela.

NOW, THEREFORE, on motion of Councilor Jashim I. Tiplani, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela authorizes Her Honor, Mayor Sitti Djalía A. Turabin-Hataman to enter into a Deed of Donation by and between the City Government of Isabela and the Department of Education – Isabela City Schools Division in relation to the HAPIsabela Teledukasyon Program.
