A RESOLUTION INVITING THE MANAGEMENT OF J&T EXPRESS TO ATTEND THE REGULAR SESSION OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF ISABELA, PROVINCE OF BASILAN, ON SEPTEMBER 22, 2021 (WEDNESDAY), 9:30 AM AT THE SESSION HALL OF THE SANGGUNIANG PANLUNGSOD, 2ND FLOOR, SP BUILDING, CITY HALL COMPLEX, SUNRISE BARANGAY, THIS CITY TO UPDATE THE AUGUST BODY OF THE STATUS OF THEIR COURIER SERVICE FOLLOWING THE RECENT ISSUE OF THEIR DELIVERY SERVICE WITHIN THE CITY OF ISABELA.

Whereas, It is the policy of the state and of the local government units to ensure that the general welfare of its constituents will always be protected and upheld;

Whereas, RA 7160, otherwise known as the Local Government Code of 1991 explicitly states that the local government units have the responsibility to ensure that business establishments shall conform to the laws and regulations applicable to them and shall have jurisdiction over the operations and conduct of these establishments;

Whereas, J&T Express is an international company engaged in the express delivery industry;

Whereas, the said courier service is also serving the people of Basilan, most especially in the City of Isabela;

Whereas, last month, an announcement was made by the courier service that J&T is no longer serving Isabela City clients, prompting most of the people of Isabela City engaged in online selling to express their dismay over the above-mentioned issue;

Whereas, among the issues raised is that most Online Sellers of online selling company Shopee, are no longer catering Isabela buyers;

Whereas, with the different issues being raised by concerned citizens, particularly those engaged in Online Shopping, there is a need for the City Council to invite the representatives of the above-mentioned express delivery company to update the august body on the status of their delivery service;


NOW, THEREFORE, on motion of Councilor Sara S. Ismael, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, requests the J&T Express to attend the next regular session of the Sangguniang Panlungsod of the City of Isabela de Basilan on September 22, 2021, 9:30am at the Session Hall of the Sangguniang Panlungsod, 2nd Floor, SP Building, City Hall Complex, Sunrise, this City, to update the august body of the status of their courier service following the recent issue of their delivery service in Isabela City.
