**A RESOLUTION CONCURRING RESOLUTION NO. 17, S. 2021, OF THE EXECUTIVE COMMITTEE OF THE CITY DEVELOPMENT COUNCIL, APPROVING THE PROPOSED FORESHORE DEVELOPMENT AND MANAGEMENT PLAN (CFDMP), CY 2021-2030, FOR THE CITY OF ISABELA.**

**WHEREAS**, Sec. 4(48), of RA 8550, otherwise known as the Philippine Fisheries Code of 1998, defining foreshore land as a string of land margining a body of water between the low water line and the upper limit or wave wash at high usually marked by a beach scarp or hem;

**WHEREAS**, the formulation of CFDMP will provide a blueprint for the regulation of various developmental activities in foreshore lands which shall serve as a guidepost to curb the effects of natural disasters along coastal and foreshore areas;

**WHEREAS**, the Foreshore Development and Management Plan will be the guiding framework for the City's Foreshore Council/Board, in achieving the advancement of social economic in the quality of human life among stakeholders;


