A RESOLUTION RESPECTFULLY REQUESTING THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES (NCIP), REGION 9, TO EXPEDITE THE ISSUANCE OF THE CERTIFICATE OF AFFIRMATION TO HON. MARY MAY B. JULHARI, BEING THE DULY SELECTED INDIGENOUS PEOPLE'S MANDATORY REPRESENTATIVE (IPMR), TO THE SANGGUNIANG PANLUNGSOD, CITY OF ISABELA, PROVINCE OF BASILAN.

WHEREAS, Ltr. (b) of Sec. 457, of Republic Act 7160, otherwise known as Local Government Code of 1991, provides for the membership of the indigenous cultural communities or other sectoral representatives in the Sanggunian;

WHEREAS, Hon. Mary May B. Julhari, is the duly selected Indigenous Peoples' Mandatory Representative (IPMR) to the Sangguniang Panlungsod, City of Isabela, Province of Basilan;

WHEREAS, by virtue of Resolution No. 08-078-2021, dated November 9, 2021, of the NCIP Commission En Banc, the term of the previous Indigenous Peoples' Mandatory Representative (IPMR) to the Sanggunian, ended last December 31, 2021;

WHEREAS, there is the need to immediately fill up the vacant seat in the sanggunian, to have a proper representation in the council, pending legal procedures being conducted by the National Commission on Indigenous Peoples (NCIP).

NOW WHEREFORE, upon motion of Councilor Yusop I. Abubakar, duly seconded by all members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of Isabela City, Basilan Province, respectfully requests ohe National Commission on Indigenous Peoples (NCIP), Region 9, to expedite the issuance of the Certificate of Affirmation to Hon. Mary May B. Julhari, being the duly selected Indigenous People's Mandatory Representative (IPMR), to the Sangguniang Panlungsod, City of Isabela, Province Of Basilan.


