A RESOLUTION RECOMMENDING TO HER HONOR, MAYOR SITI DJALIA T. HATAMAN, THIS CITY, THE RESUMPTION OF OPERATION OF THE BASILAN SPORTS AND RECREATIONAL DEVELOPMENT, INC. (BSRDI), UPON COMPLIANCE OF THE PROVISIONS OF MEMORANDUM CIRCULAR NO. 2022-003, OR THE GUIDELINES ON THE RESUMPTION OF COCKPIT OPERATIONS, UNDER LEVEL 2 OR LOWER.

WHEREAS, Memorandum Circular No. 2022-003, or the Guidelines on the Resumption of cockpit Operations under Level 2 or lower, clearly provides for the strict compliance essential policies during operations of cockpits;

WHEREAS, the Sangguniang Panlungsod, directs the Management of BSRDI, to strictly adhere and comply with all the provisions of MC No. 2022-003,

particularly on the "No Physical Exchange of Cash and No Oral Placing of Bets anywhere the cockpit", and the strict enforcement and monitoring of adoption of minimum public health standards and technology-based betting, as a requirement in the resumption of cockpits under level 2 or under;

WHEREAS, compliance of the provisions of MC No. 2022-003, will qualify any cockpits located under level 2 or lower its resumption of operations.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of Isabela City, Province of Basilan, requests the Management of the Basilan Sports and Recreational Development, Inc.(BSRDI), this City, to comply with Memorandum Circular No. 2022-003, or the Guidelines on the Resumption of Cockpit Operations, under level 2 or lower.


