A RESOLUTION ADOPTING THE MANUAL ON FREEDOM OF INFORMATION.

WHEREAS, pursuant to Section 28, Article II of the 1987 Constitution, the State adopts and implements a policy of full public disclosure of all its transactions involving public interests subject to reasonable conditions prescribed by law;

WHEREAS, Article III, Section 7, of the 1987 Constitution, guarantees the right of the people to information on matters of public concern;

WHEREAS, City Ordinance No. 19-536, is an Ordinance Operationalizing Freedom of Information and Providing for a Mechanism for the Disclosure of Public Records in Isabela City, Basilan Province, and Providing Penalties for Violation Thereof;

WHEREAS, the purpose of the FOI Manual is to provide the process to guide and assist the Agency in dealing with requests of information received under Executive Order No. 2, on Freedom of Information;

WHEREAS, in compliance with RA No. 10173, of the Data Privacy Act of 2012, the Freedom of Information is committed to ensure that all personal data will be safeguarded and protected.


NOW, WHEREFORE, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by all members present,
