A RESOLUTION RECOGNIZING HONORABLE MARY MAY B. JULHARI, AS THE DULY AND LEGALLY SELECTED ICCS/IPS REPRESENTATIVE IN THE SANGGUNIANG PANLUNGSOD OF ISABELA CITY, PROVINCE OF BASILAN, AND CHAIRMAN, COMMITTEE ON INDIGENOUS PEOPLES.

WHEREAS, Section 457(b), of Republic Act 7160, or the Local Government Code of 1991, provides for the representation from other sectors, including the urban poor, indigenous cultural communities, or disabled persons, in the Sangguniang Panlungsod;

WHEREAS, pursuant to Republic Act No. 8371, of the Indigenous Peoples Rights Act of 1997, and its Implementing Rules and Regulations, the ICCs/IPs shall be given mandatory participation in all policy-making bodies and other local legislative councils, and shall enjoy the same privileges as the regular members of the legislative bodies;

WHEREAS, Certificate of Affirmation dated March 14, 2022, issued by Director Ferdousi S. Cerna, Regional Director, National Commission on Indigenous Peoples, Region IX, affirms Honorable Mary May B. Julhari, as the duly

and legally selected ICCs/IPs Representative in the Sangguniang Panlungsod of Isabela City, Province of Basilan, pursuant to NCIP Administrative Order No. 03, s. 2018.

NOW, WHEREFORE, upon motion of Councilor Candu I. Muarip, duly seconded by all members present,

BE IT RESOLVED, that the Sangguniang Panlungsod of Isabela, Province of Basilan, recognizes Honorable Mary May B. Julhari, as the duly and legally selected ICCs/IPs Representative in the Sangguniang Panlungsod of Isabela City, Province Of Basilan, and Chairman, Committee on Indigenous Peoples.


