**AN ORDINANCE LIFTING THE IMPLEMENTATION OF ORDINANCE 21-680, PRESCRIBING CURFEW HOUR WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ISABELA, PROVINCE OF BASILAN.**

**WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the general welfare";

**WHEREAS**, Basilan Province and Isabela City in particular is under Alert Level 2, which allow more intra-zonal and inter-zonal travels of people and bringing more opportunities especially on the business and tourism sectors;


**SECTION 2. EFFECTIVITY.** This ordinance shall take effect immediately upon approval.
