"AN ORDER RECONSTITUTING THE CITY SOLID WASTE MANAGEMENT BOARD OF ISABELA CITY, BASILAN PROVINCE"

WHEREAS, Section 12 of Republic Act 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000", mandates the creation in every city of a Solid Waste Management Board which shall prepare, submit and implement a plan for the safe and sanitary management of solid wastes generated in areas under its geographic and political coverage;

WHEREAS, Section 74 of the Isabela City Ordinance No. 21-617 otherwise known as "An Ordinance Providing for the Environment Code of Isabela City" recognizes the roles and functions of the City Solid Waste Management Board in the developmental and environmental undertakings particularly in the preparation/formulation of plans and implementation of programs, projects and activities designed for the proper waste management of the city;

WHEREAS, it is vital to reconstitute the board to update its composition and strengthened its membership and include various sectors that have key roles in the formulation and implementation or execution of the City Solid Waste Management (SWM) Plan;

NOW THEREFORE, I, SITTI DJALIA TURABIN HATAMAN, Mayor of the City of Isabela, Basilan Province, by virtue of the powers vested in me by law, do hereby reconstitute the City Solid Waste Management Board of Isabela City, Basilan Province.

SECTION 1. Composition. The City Solid Waste Management Board shall be composed of the following:

SECTION 2. Duties and Responsibilities. The City Solid Waste Management Board shall perform the following duties and responsibilities:

- (a) Develop the City Solid Waste Management Plan that shall ensure the long-term management of solid waste, as well as integrate the various solid waste management plan and strategies of the component barangays;

- (b) Adopt measures to promote and ensure the viability and effective implementation of Solid Waste Management programs in all component barangays;
- (c) Monitor the implementation of the City Solid Waste Management Plan through its various political subdivisions and in cooperation with the private sectors and non-government organizations (NGOs);
- (d) Adopt specific revenue-generating measures to promote the viability of the SWM plan;
- (e) Convene regular meetings for purposes of planning and coordinating the implementation of the SWM plans of the component barangays;
- (f) Oversee the implementation of the SWM plan;
- (g) Review every two (2) years or as the need arises the City SWM plan for purposes of ensuring sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of solid waste management;
- (h) Develop the specific mechanics and guidelines for the implementation of the City SWM plan;
- (i) Recommend to appropriate local government authorities' specific measures or proposals for franchise or build-operate-transfer agreements with duly recognized institutions, pursuant to RA 6967, to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling or disposal of city solid waste. The proposals shall take into consideration appropriate government rules and regulations on contracts, franchises and build-operate-transfer agreements;
- (j) Provide the necessary logistical and operational support to component barangays;
- (k) Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem;
- (l) Coordinate the efforts of component barangays in the implementation of the City SWM plan;
- (m) Call on any concerned agency or sector, as it may deemed necessary, for support or other appropriate action.

SECTION 4. FUNCTIONS OF TECHNICAL WORKING COMMITTEE (TWC). The Technical Working Group will provide assistance in the formulation and updating of the City Solid Waste Management Plan and in the integration of various solid waste management plans and strategies of all component barangays. As well as to provide technical assistance to carry out the functions of the board.

SECTION 5. SECRETARIAT. The City General Services Office shall serve as the Secretariat and shall be responsible in providing administrative support, documentation, consolidation and preparation of minutes as well as perform such other assistance as may be required in the discharge of their function.

SECTION 6. REPEALING CLAUSE. All other order, issuances and memoranda issued inconsistent herewith are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY: This Order shall take effect immediately and supersedes all other related orders.
