**AN ORDER DESIGNATING BARANGAY INFORMATION OFFICERS WITH MINIMUM QUALIFICATION REQUIREMENTS AND SERVICE TENURE IN ISABELA CITY.**

WHEREAS, the Isabela City Barangay Information Officers Network (Isabela City BIONet) is carrying out all necessary measures to effectively and efficiently deliver relevant, accurate and timely news in their respective barangays;<sup>7</sup>

WHEREAS, the Department of Interior and Local Government Regional Office IX issued a memorandum dated August 27, 2020 enjoining all Punong Barangays to designate an Information Officer who shall serve as the designated spokesperson of the barangay;

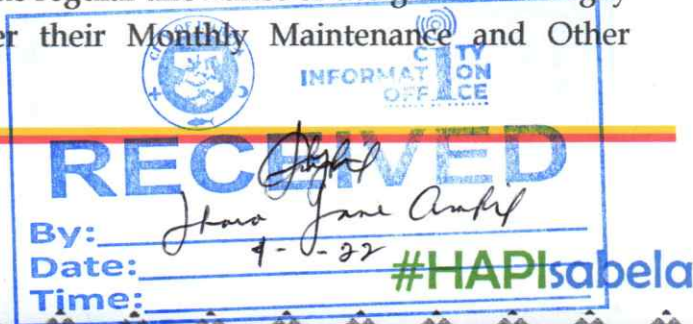
WHEREAS, Isabela City Barangay Information Officers Network (Isabela City BIONet) Orientation was conducted on September 2020 whereby 45 Barangay Information Officers were designated by their respective Punong Barangay;

WHEREAS, the Department of Interior and Local Government Regional Office IX issued ADVISORY dated December 11, 2020 and Joint Resolution No. 11 of RIATF Series 2020 which states that *"All local government units are requested to provide necessary financial support to the Barangay Information Officers Network (BION) which seeks to provide timely, accurate, and relevant information for the government and the people, if availability of funds warrant."*

WHEREAS, Executive Order No. 037 signed on December 2020 affirms designation of 45 Barangay Information Officers duly designated and appointed by their respective Punong Barangay;

WHEREAS, in order to sustain daily operations and assistive services provided for by Barangay Information Officers in the City of Isabela in the deliverance of their actual duties and functions in their respective jurisdiction as spokesperson of barangay, regular financial support is respectfully requested;

NOW THEREFORE, I, SITTI DJALIA A. TURABIN-HATAMAN, City Mayor, by the power vested in me by law, do hereby REQUEST all Punong Barangay of the City of Isabela to apportion funds intended for the regular allowance of designated Barangay Information Officers to be funded under their Monthly Maintenance and Other Operating Expenses (MOOE).

The City Information Office shall also allocate from its budget a counterpart assistance of Php 1,000.00 per month for the communication allowances of all 45 designated Barangay Information Officers, provided monthly accomplishment report and other required documents are submitted to the same office.

This order shall take effect starting January 2022.
