**ORGANIZING THE PEACE AND ORDER COUNCIL (CPOC) AUDIT TEAM OF THE
CITY OF ISABELA, PROVINCE OF BASILAN**

WHEREAS, the Peace and Order Council (POC) is the government's platform for stronger collaboration of the LGU with law enforcement agencies and the community to fight criminality, illegal drugs, insurgency, and violent extremism, and it creates an enabling environment among its members to harmonize and effectively implement peace and order and public safety activities;

WHEREAS, Section 9 of DILG Memorandum Circular No. 2019-143 or the Omnibus Guidelines for Peace and Order Councils (POCs) reiterates that the POC Performance Audit shall be conducted annually to identify the compliance rating of sub-national POCs and POC Secretariats;

WHEREAS, DILG Memorandum Circular No. 2022-013 dated February 16, 2022 calls for the conduct of CY 2019 and 2021 Peace and Order Council (POC) Performance Audit ;

WHEREAS, DILG MC No. 2022-013 mandates the creation and establishment of a City POC Audit Team to be composed of the DILG, PNP, PDEA and CSO/NGO.

NOW, THEREFORE, I, SITTI DJALIA T. HATAMAN, City Mayor of Isabela City, Province of Basilan, by virtue of the power vested in me by law, do hereby **ORDER**:
