"AN ORDER RECONSTITUTING THE LOCAL SCHOOL BOARD IN THE CITY OF ISABELA, BASILAN"

WHEREAS, Article 184 of the Rules and Regulation Implementing Republic Act No. 7160 mandates the establishment of the Local School Board (LSB)

WHEREAS, the City Government of Isabela recognizes the importance of Education as a great tool in directing the City towards a progressive community;

WHEREAS, the recent change in the leadership of Department of Education of Isabela City requires the reconstitution of the LSB;

WHEREAS, based on the premises, the City Government of Isabela would like to ensure the continuity of the functions and programs of the LSB,

NOW THEREFORE, I SITTI DJALIA A. TURABIN-HATAMAN, by virtue of the power vested in me by the Local Government Code of 1991 and other existing laws, do hereby order the Reconstitution of The Local School Board.

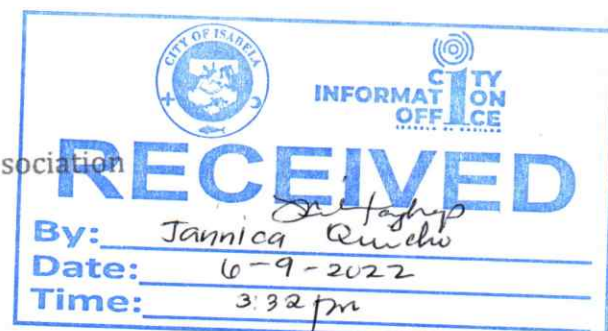

Section 2. **DUTIES AND RESPONSIBILITIES** – The LSB shall have the following duties and responsibilities:

1. Determine, in accordance with the criteria set by the Department of Education, the annual supplementary budgetary needs for the operation and maintenance of public schools within the City and supplementary local cost of meeting such needs;
2. Authorize the City Treasurer to disburse funds from the Special education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
3. Serve as an advisory committee to the Sangguniang Panlungsod on education matters such as, but not limited to, the necessity for and the uses of appropriations for educational purposes;
4. Recommend changes in the names of public schools within the territorial jurisdiction of the local government unit for the enactment of the Sangguniang Panlungsod;
5. Serve as the consultant on the appointment of division superintendents, district supervisors, school principals and officials; and
6. Perform such other duties and functions to carry out effectively the purpose of the body.
