A RESOLUTION CONCURRING AND ADOPTING CITY DEVELOPMENT COUNCIL RESOLUTION NO. 3, S, 2022, OF THE EXECUTIVE COMMITTEE, CITY DEVELOPMENT COUNCIL, APPROVING THE REALIGNMENT OF SAVINGS FROM THE INFRASTRUCTURE PROJECTS UNDER THE 20% DEVELOPMENT FUND, CY 2020-2021, IN THE AMOUNT OF FOUR MILLION FOUR HUNDRED NINETY SIX THOUSAND FOUR HUNDRED NINETY THREE (P4,496,493.91), AND 91/100 PESOS.

WHEREAS, Sec. 16, of the Local Government Code of 1991, provides th,at every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, the City Government of Isabela acquired savings from the 20% Development Fund Infrastructure Projects, in the amount of Four Million Four Hundred Ninety Six Thousand Four Hundred Ninety Three (P4,496,493.91) and 91/100 Pesos, shall be realigned to the proposed Embankment Project at the City Gymnasium Ground, at Binuangan Barangay, Isabela City, Province of Basilan;

WHEREAS, City Development Council Resolution No. 3, series of 2022, approves the realignment of savings from the infrastructure projects under the 20% Development Fund, for CY 2020-2021, in the amount Four Million Four Hundred Ninety Six Thousand Four Hundred Ninety Three (P4,496,493.91) and 91/100 Pesos.
