**AN ORDINANCE REPEALING CITY ORDINANCE NO. 21-619, PROVIDING THE INTERNAL RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD OF ISABELA, PROVINCE OF BASILAN.**

**WHEREAS;** Sec. 50, of Republic Act 7160, otherwise known as the Local government Code of 1991, provides that, on the first regular session following the election of its members and within ninety (90) days thereafter, the sanggunian concerned shall adopt or update its existing rules or procedure;

**WHEREAS,** the Internal Rules and Procedures cannot be considered in the form of an ordinance because by nature it is only a by-law and procedural;

**WHEREAS,** an ordinance is an authoritative decree or direction being set-forth by a governmental authority, to be strictly adhered by the majority;

**NOW**, Be it ordained by the Sangguniang Panlungsod of Isabela City, Province of Basilan, **THAT**

**SECTION 1. REPEALING.** That City Ordinance No. 21-619, providing the Internal Rules and Procedure of the Sangguniang Panlungsod of Isabela, Province of Basilan, is hereby repealed.

**SECTION 2. EFFECTIVITY,** this Ordinance shall take effect immediately in accordance to the provision of law.


