**A RESOLUTION GRANTING THE ROOSTER CITY COCKPIT, BINUANGAN, ISABELA CITY, PERMIT TO CONDUCT COCKFIGHTS EVERY SATURDAY FOR THE MONTH OF AUGUST.**

**WHEREAS**, Sec. 458(v), of Republic Act 7160, otherwise known as the Local Government Code of 1991, authorize and license the establishment, operation, and maintenance of cockpits, and regulate cockfighting and commercial breeding of gamecocks;

**WHEREAS**, the management of the Rooster City Cockpit suffered economic setbacks which resulted from the two (2) years temporary suspension of operation brought by the pandemic;

**WHEREAS**, the additional sultada days on August 6, 13, 20, and 27, will provide financial relief to employees and management of the Rooster City Cockpit, to recover financially from its losses.

**NOW, WHEREFORE**, upon motion of Councilor Alan Ritchie Luis B. Blel, duly seconded by all members present,
