**ORDINANCE NO. 22-694**

AN ORDINANCE REALIGNING THE AMOUNT OF FOUR MILLION ONE HUNDRED EIGHT THOUSAND (4,108,000.00) PESOS, TAKEN FROM THE PROGRAMS, PROJECTS, ACTIVITIES UNDER THE 70% CITY DISASTER RISK REDUCTION MANAGEMENT (CDRRM) FUND FOR CALENDAR YEAR 2022.

After due deliberation on the matter, on motion of Councilor Bimbo E. Epping, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of **FOUR MILLION ONE HUNDRED EIGHT THOUSAND (4,108,000.00) PESOS**, taken from the programs, projects, activities under the 70% CDRRM Fund for CY 2022, to wit: Procurement of Disaster/Emergency Response Vehicle in the amount of Two Million (P2,000,000.00) Pesos; Procurement/Construction of Fire Boat with Equipment in the Amount of Eight Hundred Thousand (P800,000.00) Pesos; and Procurement of Emergency Medical Supplies/Rescue/DRRM Equipment in the amount of One Million Three Hundred Eight Thousand (P1,308,000.00) Pesos.

The amount of **TWO MILLION (P2,000,000.00) PESOS**, be realigned and re-appropriated to augment the present appropriation for the Procurement and Installation of CCTV's for Public Safety Emergencies and Disaster Management, and the remaining amount be realigned and re-appropriated to cover payment for the following to wit: Procurement of Fire pump in the Amount **EIGHT HUNDRED THOUSAND (P800,000.00) PESOS**; and Procurement and Installation of LED Wall Structure in the amount of **ONE MILLION THREE HUNDRED EIGHT THOUSAND (P1,308,000.00) PESOS**.

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.


