



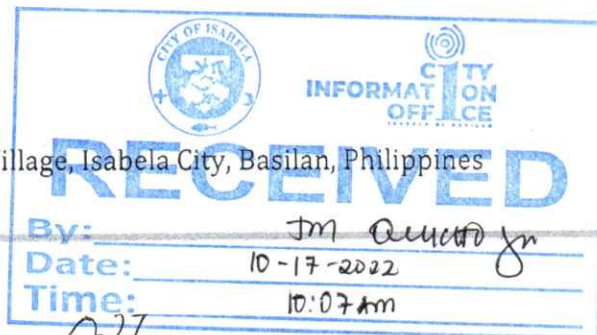

EXECUTIVE ORDER NO. 027

EXECUTIVE ORDER RECONSTITUTING THE CITY PROJECT MONITORING COMMITTEE (CPMC) OF THE CITY OF ISABELA, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES

WHEREAS, Executive Order No. 376 s. 1989 as amended by Executive Order No. 93 s. 1993, provided for the establishment of the Regional Project Monitoring and Evaluation System (RPMES) as an institutional mechanism for monitoring and evaluating projects at the national, regional, provincial, and city/municipality levels;

WHEREAS, DILG Memorandum Circular (MC) No. 2004-78, Series of 2004 was issued to facilitate organization and reconstitution of PMCs nationwide and to further strengthen the roles of said committee in ensuring transparency and accountability in the implementation of local development programs and projects;

WHEREAS, DILG MC No. 2019-188, Series of 2019 enjoined concerned local government officials to organize or reconstitute Local PMCs in their respective areas of jurisdiction;

WHEREAS, the recent local elections requires reconstitution of the CPMC due to the end of term of office of former members; and

WHEREAS, based on the above premises, the City Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the CPMC;

NOW, THEREFORE, I, SITTI DJALIA A. TURABIN-HATAMAN City Mayor of Isabela City, by virtue of the powers vested in me by the law, do hereby order the reconstitution of the CPMC of City of Isabela, with the following stipulations:

Section 1. Composition

The CPMC of the City of Isabela shall be composed of the following:

Section 2. Scope

The CPMC shall monitor and evaluate programs and projects to include the following:

- a) Programs and projects in the Local Development Investment Program (foreign-funded and GAA-funded) and those in the priority list of the President, including development projects funded from the NTA share of LGUs or supported by funds released directly to the city; and
- b) Projects funded from locally generated resources which are implemented within their respective areas.

Section 3. Duties and Functions of the CPMC

The CPMC shall perform the following functions:

- a) Provide list and schedule of all projects to be monitored to NGOs involved in the project monitoring.
- b) Collects and process reports of implementers and NGO monitors on the status of project implementation for the information of the development council.
- c) Pinpoint problems and verify information to be submitted for analysis and action of the development council.
- d) Provide feedback on the remedial actions if the development council and follow up their implementation.
- e) Prepare and disseminate periodic project monitoring report on the status of project implementation; and
- f) Elevate to higher level bodies, problems / issues which are not resolved at their level.

Section 4. Secretariat

The Office of the City Planning and Development Coordinator shall serve as secretariat to the CPMC.

The secretariat shall perform the following function:

- a) Prepare the M&E work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies;
- b) Provide the Local Chief Executive with information on the projects to be monitored by the PMC; and
- c) Facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary.

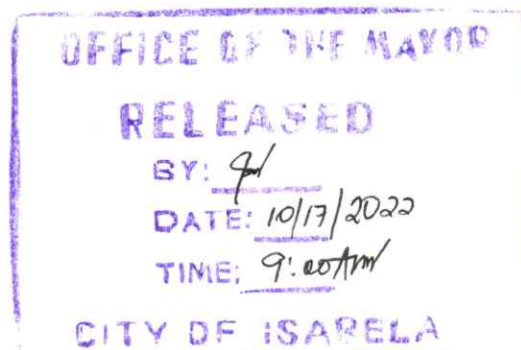
