AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION EIGHT HUNDRED NINETY ONE THOUSAND TWO HUNDRED FIFTY SIX & 13/100 (3,891,256.13) PESOS, TAKEN FROM THE UNEXPENDED TERMINAL LEAVE PAY OF THE ANNUAL BUDGET CALENDAR YEAR-2022, TO AUGMENT THE PRESENT APPROPRIATION FOR SALARIES AND WAGES (CASUAL) OFFICE OF THE SANGGUNIANG PANLUNGSOD, THIS CITY.

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – Realigning the amount of **THREE MILLION EIGHT HUNDRED NINETY ONE THOUSAND TWO HUNDRED FIFTY SIX & 13/100 (P 3,891,256.13) PESOS**, taken from the unexpended Terminal Leave pay of the Annual Budget Calendar Year 2022, be realigned and re-appropriated to augment the present appropriation for salaries and wages (Casual) Office of the Sangguniang Panlungsod, this City.
