**AN ORDINANCE REALIGNING THE AMOUNT OF FIVE HUNDRED THOUSAND (P 500,000.00) PESOS, TAKEN FROM THE SPECIAL PROGRAM ON EMPLOYMENT FOR STUDENTS (SPES) UNDER MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), TO AUGMENT THE PRESENT APPROPRIATION FOR TRAVELLING EXPENSES AND TRAINING EXPENSES, OFFICE OF THE PUBLIC EMPLOYMENT SERVICE, THIS CITY.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of **Five Hundred Thousand (P500,000.00) Pesos**, taken from the Special Program on Employment for Student (SPES) under MOOE, Office of the City Public Employment Service, this City, be realigned and re-appropriated to augment the present appropriation for the following; Travelling expenses in the amount of One Hundred Thousand (P100,000.00) Pesos; and Training expenses in the amount of Four Hundred thousand (P400,000.00) Pesos, Office of the City Public Employment service, this City.

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.
