AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION FIVE HUNDRED THIRTY FIVE THOUSAND (P1,535,000.00) PESOS, TAKEN FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), TO AUGMENT THE PRESENT APPROPRIATION FOR OTHER GENERAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES, OFFICE OF THE CITY AGRICULTURE, THIS CITY.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – Realigning the amount of **One Million Five Hundred Thirty five (P1,535,000.00) Pesos**, taken from the following appropriation items under Maintenance and Other Operating Expenses (MOOE), Office of the City Agriculture, this City to wit; Travelling Expenses in the amount of Fifty Thousand (P50,000.00) Pesos; Office Supplies expenses in the amount of Fifty Thousand (P50,000.00) Pesos; Rice PNPL-Inbred Rice Yield Amelioration in the amount of Five Hundred Fifty (P550,000.00) Pesos; Rice PNPL-Upland Rice Program expansion area in the amount of Twenty Five Thousand (P25,000.000)Pesos;

Rice PNPL-Rice Mechanization Program in the amount of Four Hundred Thousand (P400,000.00) Pesos; Alternative Staple Food Program (Corn and Cassava) –Corn Production Area in the amount of Fifty Thousand (P50,000.00) Pesos; Alternative Staple Food Program (Corn and Cassava)-Sustainable Glutinous Corn Production in the amount of Twenty Five Thousand (P25,000.00) Pesos; Vegetable Production Development Program-Gulayan sa Campo in the amount of Thirty Five Thousand (P35,000.00) Pesos; Vegetable Production Development Program-Urban Gardening in the amount of Thirty Five Thousand (P35,000.00) Pesos; Vegetable Production Development Program-School Support Services in the amount of Twenty Thousand (P20,000.00) Pesos; Vegetable Production Development Program- Vegetable Development Program in the amount of Sixty Thousand (P60,000.00) Pesos; Fisheries Development Program-Information Drive on Fishery Laws, Rules and regulations in the amount of Thirty Thousand (P30,000.00) Pesos; Agricultural Center Development- Vegetable Production Site in the amount of Thirty Five Thousand (P35,000.00) Pesos; Agricultural Center Development- Orchard Farm in the amount of Thirty Five Thousand (P35,000.00) Pesos; Agricultural Center Development-Nursery Improvement in the amount of Fifty Thousand (P50,000.00) Pesos; Agricultural Center Development-Organic Agriculture: Vermi Cast Production in the amount of Thirty Five Thousand (P35,000.00) Pesos; and Environment and natural resources Program in the amount of Fifty Thousand (P50,000.00) Pesos; be realigned and re-appropriated to augment the present appropriation for Other General Services, Maintenance and Other Operating Expenses, Office of the City Agriculture, this City.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.
