AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION TWO HUNDRED THOUSAND (P2,200,000.00) PESOS, TAKEN FROM THE APPROPRIATION UNDER THE MAINTENANCE AND OTHER OPERATING EXPENDITURES, TO AUGMENT THE PRESENT APPROPRIATION FOR OTHER GENERAL SERVICES UNDER MOOE, OFFICE OF THE CITY GENERAL SERVICES, THIS CITY.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – Realigning the amount of Two Million Two Hundred Thousand (P2,200,000.00) Pesos, taken from the appropriation under the Maintenance and Other Operating Expenditures, Office of the City General Services, this City, to wit: Training Expenses in the amount of One Hundred Thousand (P100,000.00) Pesos; Office Supplies in the amount of One Hundred Thousand (P100,000.00) Pesos;

Transportation and Delivery Expenses in the amount of One Hundred Seventy Thousand (P 170,000.00) Pesos; Furniture and fixtures in the amount of Twenty Five Thousand (P25,000.00) Pesos; Repair and maintenance-Machinery and Equipment in the amount of Three Hundred Seventy Five thousand (P375,000.00) Pesos; Repair and maintenance-Transportation and equipment in the amount of Five Hundred Thousand (P500,000.00) Pesos; Support to mortuary Services in the amount of Seventy Thousand (P70,000.00) Pesos; Improved and development Ecological Park in the amount of One Hundred Sixty Thousand (P160,000.00) Pesos; Solid Waste Management Program Insurance Expenses-Building(s) in the amount of Four Hundred fifty Thousand (P450,000.00) Pesos; Vehicle (s) in the amount of One Hundred Thousand (P100,000.00) Pesos; Other maintenance and Operating Expenses in the amount of One Hundred Fifty Thousand (P 150,000.00) Pesos; be realigned and re-appropriated to augment the present appropriation for the Other General services under the Maintenance and Other Operating Expenditures, Office of the General Services, this City.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.
