**AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION ONE HUNDRED NINETY SIX THOUSAND FOUR HUNDRED SIXTEEN AND 50/100 (P1,196,416.50) PESOS, TAKEN FROM THE SALARY SAVINGS OF VACANT POSITIONS UNDER OFFICE OF THE CITY MAYOR, THIS CITY, TO AUGMENT THE PRESENT APPROPRIATION FOR PHILHEALTH CONTRIBUTIONS UNDER PERSONAL SERVICES (PS) ACCOUNT OF THE DIFFERENT OFFICES OF THE CITY GOVERNMENT OF ISABELA.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of One Million One Hundred Ninety Six Thousand Four Hundred Sixteen and 50/100 (P1,196,416.50) Pesos, taken from the salary savings of vacant positions under Office of the City Mayor, this City, be realigned and re-appropriated to augment the present appropriation for PHILHEALTH Contributions under Personal Services (PS) Account of the different Offices of the City Government of Isabela to wit;
