**AN ORDINANCE REALIGNING THE AMOUNT OF SEVEN MILLION TWO HUNDRED FORTY THOUSAND (P7,240,000.00) PESOS, TAKEN FROM THE VARIOUS PROGRAM OF THE OFFICE OF THE CITY MAYOR, TO AUGMENT THE PRESENT APPROPRIATION UNDER MAINTENANCE AND OTHER OPERATING EXPENSES.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of Seven Million Two Hundred Forty Thousand (P7,240,000.00) Pesos, taken from various Program of the Office of the City Mayor, to wit; Other Maintenance and Material expenses in the amount of One Million (P1,000,000.00) Pesos; Cable, Satellite, Telegraph and Radio Expenses in the amount of One Hundred Fifty Thousand (P150,000.00) Pesos; Survey Expenses in the amount of Twenty Thousand (P20,000.00) Pesos; Legal Expenses in the amount of Ninety Thousand (P90,000.00) Pesos; Security Services in the amount of Four Hundred Eighty Thousand (P480,000.00) Pesos;

Other General Services in the amount of Three Million (P3,000,000.00) Pesos; Repair and Maintenance-Infrastructure in the amount of Six Hundred Thousand (P600,000.00) Pesos; Repair and Maintenance-Building and other structure in the amount of Five Hundred Thousand (500,000.00)Pesos; Repair and Maintenance-Office Equipment in the amount of One Hundred Fifty Thousand (P150,000.00) Pesos; Repair and Maintenance –Transportation Equipment in the amount of Four Hundred Fifty Thousand (P450,000.00) Pesos; Insurance expenses in the amount of One Hundred Eighty Thousand (P180,000.00) Pesos; Advertising Expenses in the amount of Forty Thousand (P40,000.00) Pesos; Transportation and Delivery Expenses in the amount of Forty Thousand (P40,000.00) Pesos; Rent Expenses in the amount of Forty Thousand (P40,000.00) Pesos; Support to Indigenous People Community in the amount of Five Hundred Thousand (P500,000.00) Pesos; be realigned and re-appropriated to augment the present appropriation under Maintenance and Other Operating Expenses to wit; LCP Dues in the amount of Four Hundred Thirty (P430,000.00) Pesos; Fuel, Oil and Lubricant Expenses in the amount of Five Hundred Thousand (P500,000.00) Pesos; Representation Expenses in the amount of Four Million Eight Hundred Ten Thousand (P4,810,000.00) Pesos; Donation in the amount of One Million (P1,000,000.00) Pesos; Other Maintenance and Operating Expenses in the amount of Five Hundred Thousand (P500,000.00) Pesos, Office of the City Mayor, this City.

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.
