AN ORDINANCE REALIGNING THE AMOUNT OF FIVE HUNDRED SEVENTY SIX THOUSAND TWO HUNDRED FORTY SEVEN & 54/100 (P576,247.54) PESOS, TAKEN FROM THE SALARY SAVINGS UNDER PERSONAL SERVICES ACCOUNT OF THE OFFICE OF THE CITY TREASURER, OFFICE OF THE CITY GENERAL SERVICES AND OFFICE OF THE CITY ENGINEER, ALL OF THIS CITY, TO COVER PAYMENTS FOR TERMINAL LEAVE BENEFITS OF THE CITY EMPLOYEES WHO PASSED AWAY.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – Realigning the amount of Five Hundred Seventy Six Thousand Two Hundred Forty Seven and 54/100 (P576,247.54) Pesos, taken from the salary savings under Personal Services Account to wit; Office of the City Treasurer in the amount of Two Hundred Ten Thousand Eight Hundred Fifty Four & 91/100 (P210,854.91) Pesos;


