AN ORDINANCE DECLARING THE AMOUNT OF THREE MILLION ONE HUNDRED NINETY FIVE THOUSAND THREE HUNDRED TWENTY FIVE & 61/100 (P3,195,325.61) PESOS, AS SAVINGS FROM THE CURRENT OPERATING EXPENDITURES, UNDER PERSONAL SERVICES-TERMINAL LEAVE BENEFITS, OFFICE OF THE SANGGUNIANG PANLUNGSOD, THIS CITY.

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

SECTION 1. The amount of Three Million One Hundred Ninety Five Thousand Three Hundred Twenty Five & 61/100 (P3,195,325.61) Pesos be declared as savings, with the appropriate recommendation from the Local Finance Committee, this City.






