EXECUTIVE ORDER NO. 038-A

AN ORDER CREATING BARANGAY AFFAIRS AND GOVERNANCE OFFICE (BAGO) PRESCRIBING ITS STRUCTURE, FUNCTIONS AND OTHER PURPOSES

WHEREAS, Section 384 of R.A No. 7610 otherwise known as the Local Government Code of 1991 provides that, "As the basic political unit, the barangay serves as primary planning and implementing unit of government policies, plans, programs, projects and activities in the community and as a forum wherein the collective views of the people may be expressed, crystallized and considered, and where disputes may be amicably settled";

WHEREAS, the creation of the Barangay Affairs and Governance Office (BAGO) becomes imperative to provide and facilitate technical and non-technical assistance to the City Mayor on all matters affecting barangays;

NOW THEREFORE I, SITTI DJALIA A. TURABIN HATAMAN, City Mayor of Isabela City, Basilan Province, by virtue of the powers vested in me by law, do hereby order as follows:

SECTION 1. ESTABLISHMENT OF THE BARANGAY AFFAIRS AND GOVERNANCE OFFICE (BAGO). There is hereby created a Barangay Affairs and Governance Office (BAGO) which shall perform the following functions:

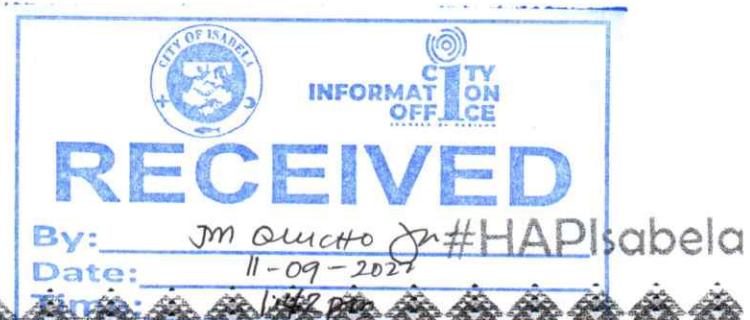
- a) Provide technical assistance to the City Mayor in the exercise of its supervisory function over the barangays;
- b) Serve as the city's coordinating body in the planning of development projects and programs in the barangay as well as in the implementation of government policies and activities in the community;
- c) Facilitate in the conduct of Barangay capability building activities in achieving the ideals of good governance and ensure the observance of the consultative and participative process in all aspects of its decision-making;
- d) Conduct regular engagements with barangay officials and constituents in their respective communities in order for the City Mayor to be thoroughly appraised of the concerns and conditions of barangays;
- e) Upon request of the barangay officials or constituents, undertake interventions on matters affecting the general welfare of the community;
- f) Establish linkages with organizations of barangay officials, Civil Society Organizations and government agencies to further improve and enhance delivery of services in the barangays;

- g) Exercise such other functions as may be necessary to carry out the objectives of this Order.


SECTION 2. OFFICE ADMINISTRATION. Pending the creation of plantilla positions thru an ordinance, the Barangay Affairs and Governance Office (BAGO) shall be managed and administered by the Office of the City Administrator.

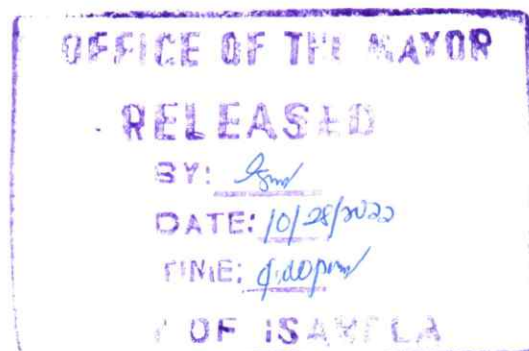
SECTION 3. APPROPRIATION. The Office of the City Mayor shall appropriate the necessary budget for the operation of the Barangay Affairs and Governance Office (BAGO) subject to accounting rules and regulations.

SECTION 4. SEPARABILITY CLAUSE. Should any provision of this Executive Order be subsequently declared unconstitutional, the rest of the provisions not so declared shall remain to be in full force and effect.

SECTION 5. REPEALING CLAUSE. All executive issuances, or provisions thereof, which are inconsistent with any provisions hereof are hereby accordingly repealed, amended and/ or revised.
