AN ORDINANCE REALIGNING THE AMOUNT OF ONE HUNDRED EIGHTY SEVEN THOUSAND EIGHT HUNDRED FORTY EIGHT & 50/100 (P 187,848.50) PESOS, TAKEN FROM PERSONAL SERVICES-SALARIES AND WAGES REGULAR, OFFICE OF THE SANGGUNIANG PANLUNGSOD, THIS CITY, FOR PAYMENT OF 14TH MONTH PAY OF THE FORMER CITY COUNCILORS.

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:


