**AN ORDINANCE DECLARING THE AMOUNT OF FOUR HUNDRED TWENTY FIVE THOUSAND (P425,000.00) PESOS, AS SAVINGS TAKEN FROM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), FOR PAYMENT OF COLLECTIVE NEGOTIATION AGREEMENT.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**SECTION 1.** The amount of Four Hundred Twenty Five Thousand (P 425,000.00) Pesos, taken from Maintenance and other Operating Expenses (MOOE), Office of the Sangguniang Panlungsod, this City be declared savings to wit;
