**AN ORDINANCE REALIGNING THE AMOUNT OF TWO HUNDRED EIGHT THOUSAND (P208,000.00) PESOS, TAKEN FROM THE REFLECTED PROGRAMS AND ACTIVITIES FOR BUREAU OF FIRE PROTECTION (BFP) UNDER PEACE AND ORDER AND PUBLIC SAFETY PLAN FOR CY 2022, FOR PURCHASE OF TWO (2) DJI MAVIC DRONE AND PURCHASE AND INSTALLATION OF THREE (3) FIRE HYDRANTS. FURTHER REALINGING THE AMOUNT OF SEVEN HUNDRED SEVENTY THOUSAND (P770,000.00) PESOS, TAKEN FROM THE REFLECTED PROGRAMS AND ACTIVITIES FOR BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) UNDER PEACE AND ORDER AND PUBLIC SAFETY PLAN FOR CY 2022, FOR THE CONSTRUCTION OF ADDITIONAL CELLS AND OFFICE FOR BJMP.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**SECTION 1.** Realigning the amount of Two Hundred Eight Thousand (P208,000.00) Pesos, taken from the reflected Programs and Activities for Bureau of Fire Protection (BFP) under Peace and Order and Public Safety Plan for CY 2022, to wit;

1. Purchase of Five (5) DJI Mavic Drone	P 70,000.00
2. Purchase and Installation of Eight (8) Fire Hydrants	138,000.00
<b>TOTAL</b>	<b>P 208,000.00</b>

The same amount will be realigned and re-appropriated for the following Programs and Activities for Bureau of Fire Protection (BFP) under Peace and Order and Public Safety Plan for CY 2022, to wit;

1. Purchase of Two (2) DJI Mavic Drone	P 70,000.00
2. Purchase and Installation of Three (3) Fire Hydrants	138,000.00
<b>TOTAL</b>	<b>P 208,000.00</b>

Further Realigning the amount of Seven Hundred Seventy Thousand (P770,000.00) Pesos, taken from the reflected Programs and Activities for Bureau of Jail Management and Penology (BJMP) under Peace and Order and Public Safety Plan for CY 2022, to wit;

1. Procurement of Four (4) units 5.56 mm rifle for jail security	P 660,000.00
2. Procurement of Ammunition and other related expenses	110,000.00
<b>TOTAL</b>	<b>P 770,000.00</b>

The said amount will be realigned and re-appropriated for the construction of Additional Cells and Office for Bureau of Jail Management and Penology (BJMP) under Peace and Order and Public safety Plan for CY 2022.
