AN ORDINANCE REVERTING THE AMOUNT OF THREE MILLION ONE HUNDRED FORTY FIVE THOUSAND (P3,145,000.00) PESOS, TAKEN FROM THE IDENTIFIED APPROPRIATION ITEMS MAINTENANCE AND OTHER OPERATING EXPENDITURES UNDER EXECUTIVE OFFICES FOR PAYMENT OF COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVE FISCAL YEAR 2022.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:


SECTION 1. - The amount of Three Million One Hundred Forty Five Thousand (P3,145,000.00) Pesos, taken from the identified appropriation items Maintenance and Other Operating Expenditures under Executive Offices, be reverted and re-appropriated for payment of Collective Negotiation Agreement (CNA) Incentive Fiscal Year 2022, per DBM Budget Circular NO. 2011-3 dated October 19, 2022, for City Government Officials and Employees.

SECTION 2. – This Ordinance shall take effect upon its approval.
