AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 01, OF THE CITY GOVERNMENT OF ISABELA, PROVINCE OF BASILAN, FOR CALENDAR YEAR 2022, IN THE AMOUNT OF THREE MILLION FIVE HUNDRED SEVENTY THOUSAND (P3,570,000.00) PESOS.
