AN ORDINANCE REALIGNING THE AMOUNT OF NINE MILLION NINETY TWO THOUSAND SIX HUNDRED SEVENTY FOUR & 39/100 (P9,092,674.39) PESOS, TAKEN FROM THE SAVINGS UNDER PERSONAL SERVICES OF THE DIFFERENT OFFICES, THIS CITY, FOR PAYMENT OF SERVICE RECOGNITION INCENTIVE (SRI) FISCAL YEAR 2022.
