AN ORDINANCE REALIGNING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND (P250,000.00) PESOS, TAKEN FROM CAPITAL OUTLAY VETERINARY OFFICE, THIS CITY, BE RE-APPROPRIATED FOR PURCHASE OF ONE (1) MOTORIZED RIKSHAW.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

SECTION 1. – The amount of **Two Hundred Fifty Thousand (P250,000.00) Pesos**, taken from the Capital Outlay, Veterinary Office, this City, for the purchase of Tranquilizer Gun, be realigned and re-appropriated for purchase of One (1) Motorized Rikshaw still under Capital Outlay, Veterinary Office, this City.
