EXECUTIVE ORDER NO. 025

SERIES OF 2020 *April*

**AN ORDER MANDATING THE QUARANTINE OF PERSONS  
WITH CLOSE CONTACT TO COVID-19 - POSITIVE PATIENT**

**WHEREAS**, pursuant to the guidelines from the DILG and the “Bayanihan to Heal as One Act”, as well as the various IATF guidelines, the LGUs are mandated to provide support to DOH especially in the contact tracing of persons who may have been exposed to COVID-19;

**WHEREAS**, Republic Act No 11332 also mandates the LGUs to help in monitoring and reporting of persons who may have been affected by infectious disease;

**WHEREAS**, best practices from around the world in the fight against COVID-19 show that in order to effectively contain the spread of the virus, there is a need for early identification and isolation of persons suspected of having contracted COVID-19;

**WHEREAS**, Contact-tracing is one of the best methods or pro-active steps in identifying persons exposed to COVID-19 in order to refer and transport them to DOH-designated COVID-19 Center or hospital;

**NOW, THEREFORE, I, SITTI DJALIA T. HATAMAN**, City Mayor of Isabela, by virtue of the powers vested in me by law, do hereby order as follows:

1. The following persons shall undergo a mandatory 14-day quarantine:
  - a. Persons who came in close contact with a confirmed COVID-19 patient;  
and
  - b. Members of the household of a confirmed COVID-19 patient.

2. The 14-day mandatory quarantine herein prescribed shall be completed by the subject person regardless of the result of the COVID-19 related test/s.
3. For this purpose, the BHERT, in coordination with the City Government of Isabela, the concerned Barangay, and the Contact Tracing Team, shall ensure that the aforementioned persons shall strictly comply with the 14-day mandatory quarantine.
4. The City Social Welfare and Development Office may provide necessary food assistance to the persons undergoing quarantine during the said 14-day period.

This order shall take effect immediately and shall remain effective until the Public Health Emergency declared by the President and the Community Quarantine are lifted.
