**AN EXECUTIVE ORDER CREATING THE TECHNICAL WORKING GROUP (TWG) OF THE LGU-CITY OF ISABELA DE BASILAN, TO OVERSEE THE PROJECT IMPLEMENTATION OF THE "COMMUNITIES OF INCLUSION AND RESILIENCE THROUGH COLLABORATIVE LOCAL ENGAGEMENTS" OR PROJECT CIRCLE OF THE ASIA FOUNDATION (TAF) AND THE BALAY MINDANAW FOUNDATION, INC. (BMFI) WITH SUPPORT FROM THE DEPARTMENT OF FOREIGN AFFAIRS AND TRADE (DFAT) OF THE AUSTRALIAN EMBASSY**
