**A RESOLUTION RESPECTFULLY REQUESTING MAYOR SITTI DJALIA T. HATAMAN, TO LOOK INTO THE POSSIBILITY OF PROVIDING RICE ALLOWANCES TO ALL CITIZEN ARMED FORCES GEOGRAPHICAL UNIT (CAFGU) DETACHMENTS WITHIN THE TERRITORIAL JURISDICTION OF ISABELA CITY, PROVINCE OF BASILAN.**

**WHEREAS**, Section 7, Article III, of Republic Act 7077, provides for the development, administration, organization, training, maintenance and utilization of the citizen armed force of the Armed Forces of the Philippines. *The mission of the Citizen Armed Force, or the Reserve Force, is to provide the base for the expansion of the Armed Forces of the Philippines in the event of invasion or rebellion xxx*”;

**WHEREAS**, the Citizen Armed Forces Geographical Unit (CAFGU) are components of the Armed Forces Ready Reserve detailed to Military Auxiliary Services which entails services rendered in meeting local insurgency threats;

**WHEREAS**, several CAFGUs were organized in the territorial jurisdiction of the City of Isabela, Province of Basilan, to assist in the local insurgencies, threats from lawless elements and search and rescue missions under the direct supervision of the Armed Forces of the Philippines;
