## INVITATION TO BID

Reference No. 2020-11-089

1. The *City Government of Isabela*, through the *20% Development Fund* intends to apply the sum of *Three Million Seven Hundred Eighty Two Thousand Three Hundred Twenty Five Pesos and Twenty Three Centavos (Php 3,782,325.23)* being the Approved Budget for the Contract (ABC) to payments under the contract for **CONSTRUCTION OF COVERED COURT AT SUNRISE BARANGAY, ISABELA CITY, BASILAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Isabela* now invites bids for **CONSTRUCTION OF COVERED COURT AT SUNRISE BARANGAY, ISABELA CITY, BASILAN**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *City Government of Isabela* and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm. (Monday to Friday).
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (Php 5,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The *City Government of Isabela* will hold a Pre-Bid Conference on *December 4, 2020 at 9:30 AM at the 4<sup>th</sup> Infirmery Building, Isabela City Hall Compound, Sunrise Barangay, Isabela City, Basilan*, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before *December 16, 2020 at 9:30 AM at the 4<sup>th</sup> Infirmery Building, Isabela City Hall Compound, Sunrise Barangay, Isabela City, Basilan*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened on **December 16, 2020 at 9:30 AM at the 4<sup>th</sup> Infirmery Building, Isabela City Hall Compound, Sunrise Barangay, Isabela City, Basilan** in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *City Government of Isabela* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
