A RESOLUTION RESPECTFULLY REQUESTING THE PHILIPPINE COAST GUARD, MARINA AND MARITIME POLICE, TO IMPLEMENT STRICTER MEASURES IN ACCORDANCE TO IATF PROTOCOLS, AGAINST OPERATORS OF JUNGKUNGS, KULIBUS AND OTHER SEA VESSELS, FERRYING PASSENGERS WITHOUT PERTINENT TRAVEL DOCUMENTS.

WHEREAS, sea, air and land transport were restricted and regulated in accordance to the health protocols being provided by the Inter-Agency Task Force (IATF);

WHEREAS, said restrictions and regulations as being provided, is to curtail mobility of people that will contain the spread and contamination of corona virus;

WHEREAS, there were reports of apprehensions involving jungkungs, kulibus and other small sea vessels ferrying passengers without pertinent documents, to and from Isabela City to Zamboanga City.

NOW WHEREFORE, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, respectfully requests the Philippine Coast Guard, MARINA and Maritime Police, to implement stricter measures in accordance to IATF protocols, against operators of jungkungs, kulibus and other sea vessels, ferrying passengers without pertinent travel documents.
