A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITI DJALIA T. HATAMAN, CITY MAYOR, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND DR. SITI NURUSSAMI CASALIN-AMILASAN, HOSPITAL CHIEF, BASILAN GENERAL HOSPITAL, IN CONNECTION WITH THE RURAL HEALTH UNIT PERFORMANCE COMMITMENT TO PHILIPPINE HEALTH INSURANCE CORPORATION.

WHEREAS, Republic Act No. 7875, provides for the creation of the Philippine Health Insurance Corporation, a government-owned and controlled corporation tasked with the mandate of implementing the national health insurance program of the country;

WHEREAS, Rural Health Units of Isabela City, were only capable of catering patients with less medical attention and needs;

WHEREAS, patients that need serious medical attention are being referred to hospitals that were equipped and are capable of conducting serious medical procedures;

WHEREAS, majority of the patients of the Rural Health Units of Isabela, came from less-fortunate individuals and were financially incapacitated, were being referred to Basilan General Hospital, who is a Philhealth accredited hospital.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, grants authority to Honorable Sitti Djalía T. Hataman, City Mayor, this City, to enter into a Memorandum of Agreement (MOA), by and between the City Government of Isabela and Dr. Sitti Nurussami Casalin-Amilasan, Hospital Chief, Basilan General Hospital, in connection with the Rural Health Unit Performance Commitment to Philippine Health Insurance Corporation.
